Many Nations Academy is one of several departments that serves the needs of the Native American and Alaska Native community of Portland. As a private alternative school, we contract with Portland Public Schools to serve all students (grade 9-12) who qualify to attend an alternative school. The student body population is 90% from communities of color, over 30% have IEPs, and ALL students receive free breakfast and lunch. Once schools were forced to close to in-person instruction in March 2020, we have been in constant consultation with Portland Public regarding state and district guidelines. NAYA established a Coronavirus Task Force to direct the agency on policies and procedures that would ensure the health and wellness of the community that the agency serves. The school contacted students and families to survey their preferences for instruction for the 2020-2021 SY. Taking all recommendations from the variety of stakeholders Many Nations Academy decided to adopt a hybrid instructional model for the upcoming school year. A Student Support Coach position will be created to help serve the needs of our families and students. Teachers will be working closely with an advisory group of students as they navigate the world of remote learning. ELL students and those with an IEP will be closely monitored to ensure that instruction is properly designed to meet the learning needs of each student. As is consistent with the mission and vision of Many Nations Academy, we will continue to focus on maintaining a culturally relevant learning program for our students.

NAYA Many Nations Academy is selecting Comprehensive Distance Learning as our school's Instructional Model from September 2020 through at least November 5, 2020. We will continue with the Comprehensive Distance Learning model as long as this model is required by State and ODE guidelines and also determined by Portland Public Schools.

We are selecting this model because it is being required by the State of Oregon (there are state mandated health metrics that each county must meet before a hybrid or in-person educational model can be instituted) and it is the decision made by Portland Public Schools. It also is the best decision in protecting the health and wellness of staff, students and the larger NAYA organization.

Describe the school's plan, including the anticipated timeline, for returning to Hybrid Learning or On-Site Learning consistent with the *Ready Schools, Safe Learners* guidance.

Many Nations Academy has developed a schedule where students will be enrolled in 4 Core classes, 1 Advisory class and 1 elective course for the year. Students will be able to earn a total of 6 credits by the end of the 2020-2021 SY. Mondays – Thursday the “school day” will run from 9:45 AM – 4:00 PM. Students will be expected to attend an advisory check-in daily. Students will be completing a combination of synchronous and asynchronous instruction. Students will spend time each day attending at full group-instruction as class schedules require and working on applied learning tasks. Teachers will have daily office hours that will allow for students to request assistance in completing learning targets and for parents to reach out to ask questions and receive guidance. Teachers can also schedule one-on-one or small group tutoring sessions with students as needed. Many Nations Academy will have a “soft-opening” of school that begins on September 8, 2020. During this week, instructors will be reaching out to students and parents to high-light and inform them of the structure for distance learning, attendance requirements, trouble-shooting technology and primarily to establish a positive connection with new students/families and build upon the relationships already established with returning students/families. Classes will officially begin on Monday, September 14, 2020.

On Fridays, the school day will run from 10:00 AM – 1:00 PM. This will include a one-hour Advisory group meeting, teacher office hours, time for college and career interaction, and SEL enrichment.

MNA has the technology to distribute to all enrolled students that will enable access to the distance learning curriculum. This will be distributed to students between August 31, 2020 and September 11, 2020. School supplies, course packets and art supplies will also be distributed at this time.

All enrolled students are considered PPS students and will be able to access PPS food distribution to students/families. Those families who cannot access via PPS can be registered for NAYA's food box/meal deliveries that has been in operation from the beginning of school closure (March 13, 2020).

Many Nations Academy will return to a hybrid or on-site learning model as soon as the county meets the threshold needed for such instruction and clearance from NAYA Leadership Team. Administration staff have already been working on establishing protocols and procuring materials and equipment for meeting the requirements set in the Ready Schools, Safe Learners Guidance developed by ODE.
